Completed procedures for consolidation of ALPS LOGISTICS CO., LTD. (Jan. 2025)

■Oct. 11, 2024: The tender offer for ALPS LOGISTICS CO., LTD. ended successfully, and the Group became the LOGISTEED's consolidated subsidiary.

■ Dec. 17, 2024: The company's shares were delisted from TSE Prime Market

■ Dec. 19, 2024: The company's share consolidation took effect.

■Jan. 30, 2025: The company conducted capital increase/ reduction and share buyback
