Changes of Representative Executive Officers

On February 25, 2013, Hitachi Transport System, Ltd. (herein called HTS) decided to change representative executive officers in accordance with a resolution passed by a meeting of the board of directors.

1. Purpose

HTS has extended the logistics business dramatically and achieved the mid-term business target in FY2011, 500 billion JPY service revenues, through the stable growth of 3PL business and the domestic and overseas aggressive M&A activities, since Mr. Suzuki became president of HTS in June, 2006. It remains severe business environment for HTS in FY2012, but HTS aims to achieve Vision 2015, service revenue 750 billion JPY and operation profit 45 billion JPY. This time, HTS will conduct a generation change in top management, and would like to enhance the business foundation and the company value to expand business strategies and globalization under the new management organization perspective.
