Integration of HTS Group Subsidiaries

(Reorganization to create synergy with VANTEC Group)

Hitachi Transport System, Ltd. (herein called HTS) has announced that Hitachi Transport System (Thailand), Ltd. (herein called TST) and Vantec World Transport (Thailand) Co., Ltd. (herein called VTH) will be integrated.

1. Purpose of Integration

In line with HTS's vision as "a competitive logistics company that survives against the regional competition and wins the global competition", HTS is moving toward further optimization of its regional global operations through restructuring.

Following the integration of Hong Kong and Taiwan companies in November 2013 and Singapore companies in April 2014, it is necessary to respond to the growing ASEAN market and customer's regional expansion. As such, through this integration in Thailand, HTS will aim to improve operating efficiency by consolidating resources and enhance its ability to respond to business undertakings.

(1) Method of Integration: VTH will make a full transfer of business to TST. Once complete, VTH will be liquidated.
