Vantec Hitachi Transport System (Hong Kong) Ltd. Acquires CEIV Pharma at Hong Kong International Airport

* CEIV Pharma: Abbreviation for The Center of Excellence for Independent Validator in Pharmaceutical Logistics. It is an air transport quality certification program for pharmaceutical formulated by IATA. A standard to ensure the safety, compliance and efficiency of temperature-controlled air transport of pharmaceuticals that conforms to GDP (Good Distribution Practice) around the world.
